Learn the significance of this duel between national leaders on Clinton's history and why a town once named Burrville changed its name to Clinton. The re-enactment is scheduled at 12:30 pm in the "flat" on Market Street in front of Hoskins/Lane Park.

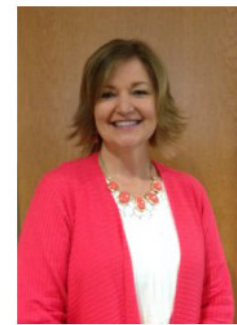

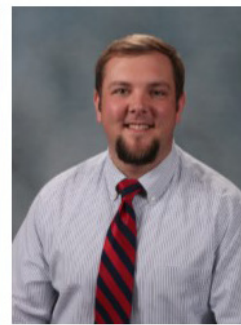

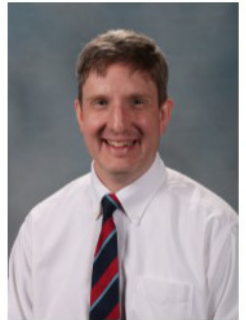

Wetland Summer Camp a success

Norris Elementary School held a Wetland Summer Camp in June. We worked with approximately 25 students total. Kindergarten and First grade students came part of the day and second, third and fourth students came the latter part of the day. During the summer camp students were able to have a hands-on approach to science exploration with the vernal pond (wetland) on Norris Elementary's campus.

Every day students were able to examine live specimens from the wetland and were involved in literacy connected to different amphibian and insects they were studying.

Some students were able to test the water quality of the wetland and swab amphibians for additional testing.

This is an annual summer camp that has been a part of the school's curriculum since 2007.

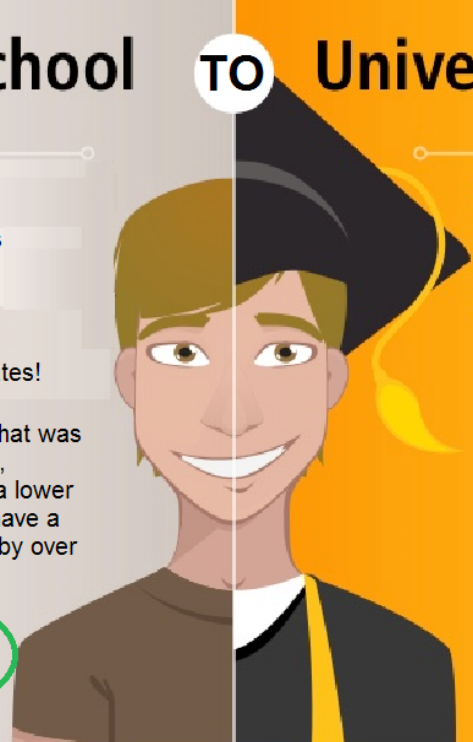

Dropout Rates lower by 22% over state average



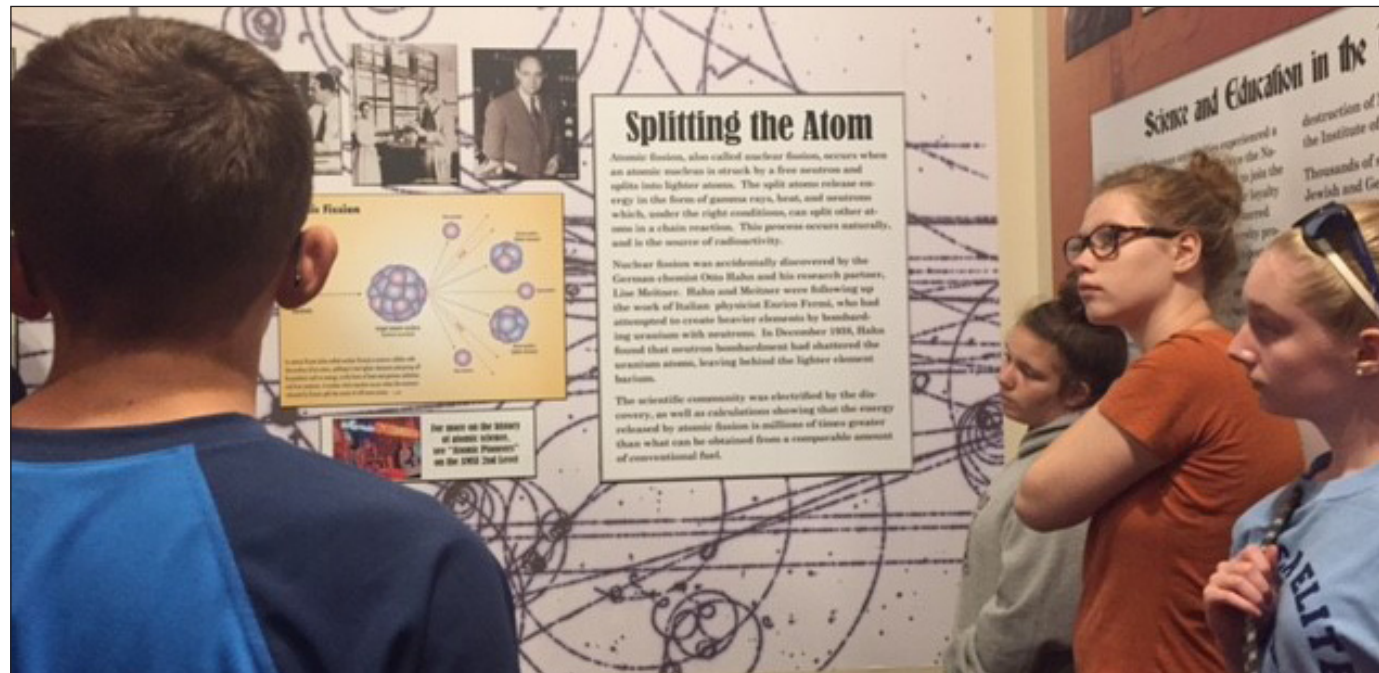
Each year, nearly 70 percent of community college freshman in Tennessee are placed in remedial courses upon enrollment in higher education. The Seamless Alignment and Integrated Learning Support (**SAILS**) program targets students that have not achieved college readiness benchmarks by introducing the college developmental curriculum into the high school senior year. Developed by K-12 teachers and higher education faculty at Chattanooga State Community College, SAILS embeds the Tennessee Board of Regents (TBR) Learning Support competencies into the high school senior year math and English courses utilizing a blended learning model. **SAILS** is a key aspect of the Governor's Drive to 55 in removing barriers to college success by allowing students to begin a higher education career prepared for credit bearing coursework.

Anderson County School's college-going rate has surpassed the State average college-going rate for the past three years by over 5%!

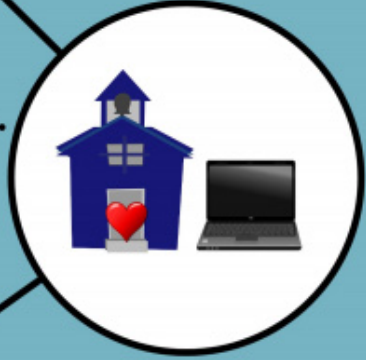

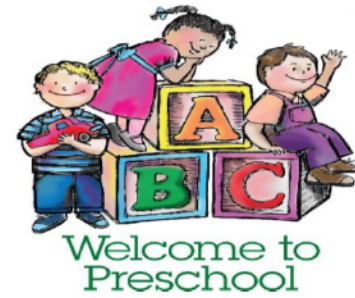

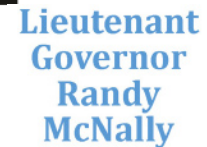
